

WZ Safe Sport

2024 Fall HOD Report

Safe Sport awareness, education and attention to procedural details help us all as a zone.

2024 was a building and growth year for WZ Safe Sport. I am excited for 2024/25 and we will have additional Safe Sport projects and proposal for Championship meet support.

As of Aug 9, 2024, We currently have 300 clubs started and in progress SSRP and 282 achieved or renewed. 190 clubs have not started. Thank you for your support and experiences.

Ideas for 2025

Optional for LSCs (many have found this effective in getting clubs certified) Safe Sport Policy

- All meet/club-hosted meets must be recognized as SSRP club to be issued a meet sanction (
 - A club/Team registering and not SSRP certified will pay double the club registration fee. Any fees paid will be used for LSC Safe Sport Education.

LSC Meet Sanction Process Idea for those LSCs requiring the club be SSRP to host meets:

- Club will send LSC Sanction Chair a request for meet sanction request includes copy of meet announcement to be sanctioned.
- The Sanction Chair will forward sanction request to Safe Sport Chair to verify if club has reached SSRP status and meets

If the club has not met recognition, the Safe Sport Chair will aid the club to reach level of required SSRP points.

Championship Meet support:

 LSC Safe Sport Team support policy would assist and work with the host team to better utilize and support the requirements for LSC hosted meets (local club chair who doesn't have to travel far to support would be ideal) These ideas would be worked on in the several months prior to the meet.

- 1. Support and organize meet safe sport staff (4 marshals minimum, preferably 2 of each gender) Could be from designated support staff or host club.
- 2. MAAPP enforced and Emergency action plan supported by Meet 360 suggestions.
- 3. Review of Meet 360 and what is mandatory.
- 4. Sanction specific support for closed deck, locker rooms, cameras and photography signage and enforcement
- 5. Safe sport tabling and pop-up changing tents.
- 6. Meet briefings for coaches, officials, volunteer timers, and marshals.

Safe Sport 2025

Goals and Activities:

- 1. Educate and share resources every 6 weeks or so with WZ LSC Chairs (activity books, athlete training, webinars, video clips, Darkness to Light, facebook)
- 2. Safe Sport leadership, continue to lead the way in SSRP recognized clubs, WZ continues to be the leader for LSC clubs renewing and recognized.
- 3. Support Safe Sport LSC/National Committee/club coordinators-continue to advertise at meets, newsletter, support emails, phone calls and zoom meetings
- 4. 2025 Budget proposal \$1000
 Assure Safe Sport is at every championship meet (athlete fellowship, meet 360, signage, head timer vests, official off duty vests) with Proposal at IES Championship meets for WZ Spring 2024 HOD
- 5. LSC Safe Sport Workshops (Always willing) Can do as conference call at Team/LSC BOD meetings. We had a session with new mental health resource at USAS for coaches and athletes and a session with Eastern Zone this August that was well attended by WZ athletes and Safe sport chairs.
- 6. WZ Safe Sport updated website, docs, and club tools
- 7. Grow SSRP Renewal numbers
- 8. Continue to connect with LSC Safe Sport Chairs (esp. newly designated) and share successes/what is working. Send emails with updates. Once we launch the new Teams app for LSC Chairs, host a zoom on how to use it.
- 1. We need to add athlete reps to the Zone SS committee (I hope to connect at Annual business meeting with athletes of the WZ.)
