#### **OLD BUSINESS**

1) Sr. Regional Task Force - The Oregon Swimming Short Course Senior Championships is one week prior to the Sectional meet. In December 2011 the meet was opened to any team from the old Region XII. Due to the lateness in getting the word out, only one team outside Oregon Swimming participated. The meet will again be open to the old Region XII clubs in December 2012 and a greater effort will be made to alert teams to the possibilities for non- sectional qualifying swimmers.

### **NEW BUSINESS**

- 1) Fee Task Force Due to the rising cost of pool rental for the sectional championships there was discussion about adding some kind of additional fee for the meet. After additional discussion it was moved, seconded and approved to immediately add a \$5.00 per swimmer per day fee.
- 2) USA Swimming Task Force Brandon Drawz has been asked to chair a USA Swimming task force on sanctions and how "road blocks" for issuing sanctions for meets with teams coming from multiple LSC's might occur. Any and all ideas are welcomed. For example a meet for clubs of a similar size rotating locations year to year and where the entire team participates.
- 3) There are approximately 750 athletes at this meet.
- 4) Inland Empire, Montana, Snake River and Alaska Swimming are talking about possible ways of combining administrative functions, championship meets, etc. The goal is to find additional ways to provide more than just the basic LSC service to the athletes. Stay tuned.
- 5) Going forward it as moved, seconded and approved for the summer meet only to have the 800 Free individual event begin at 3:30. All other days begin at 5:30.

6) Going forward for both spring and summer meets, it was moved, seconded and approved to flip the current schedule of the 800 Free Relay and the 200 Free Relay.

### **ELECTIONS**

Bruce Stratton and Robert Broyles were elected to a two year term as Treasurer and Chair. There were no other candidates. Congratulations to Bruce and Robert.

There being no further business, the meeting was adjourned at 1:50 p.m.
