- Report from the National DDEI Committee: Emily Altier; Virgil Chauncy and Emily Wang
- Report from National Disability sub-committee and/or WZ Disability Chair: Has your LSC adopted using the new parallel time standards? These new time standards can be used at LSC, Zone, Regional, and Sectional meets.
- New Business:
 - The 2025 National Diversity Select Camp applications are now open through February 9. The camp is May 1-4, 2025, in Colorado Springs, CO. Athletes must have achieved at least one National Diversity Select Camp time standard to apply. These times are the AAAA National Motivational Times for 13-14 year olds. Up to 14 athletes (for a total of 28 athletes) from each competition category will be selected based on the 2024 LCM IMX point scores. The fastest applicant in each event will be invited for a total of 14 athletes from each competition category. Only LCM times will be accepted. An additional five athletes from each competition category may be selected based on Outreach membership status.

 - Current balance in the WZ DEI account as of January 28, 2025: \$54,266.56.
 - 20 Cent Fundraising update: All payments have been received. Checks were mailed to USA Swimming to be deposited. Alaska Swimming overpaid by \$27.80 which will be credited towards their 2025 payment.

- Future multicultural meet: During the round robin discussion in November, the group talked about hosting a multicultural meet in the future or attending a meet. Possibly an African American cultural meet in the Oakland, CA, area. It could be a two-day meet with day one as a summit/camp and day two as the swim meet. Ollie is a possible contact. Kent and Virgil will check on this possibility. After the Utah WZ DEI camp we talked about hosting a multicultural meet. Let's begin discussing holding a multicultural meet in the Western Zone. We will discuss this more beginning in February.
- Future WZ DEI Camp and Summit: Would Central California (Kacy Ota) and Sierra Nevada (Alex Ongaco) be interested in hosting the next WZ DEI camp and summit in 2026 or 2027? We will discuss this more beginning in February.
