

WESTERN ZONE MINUTES Hyatt Regency Dallas Dallas, Texas September 11-17, 2017

The meeting was called to order at 4:00 pm by Dave Coddington, Western Zone Non-Coach Director. All Western Zone LSCs were represented. Elected and appointed officers present were: Sean Redmond, Coach Director, Haley Beranbaum, Disability Coordinator, Teri White, Officials' Coordinator, Denna Culpepper, Western Zone Championship Meet Coordinator, Debbie Baldwin, Secretary/Treasurer and Grant Sugaski, Athlete Representative.

M/S/P Motion to approve the minutes from the 2017 Age Group Business Forum as presented.

REPORTS OF OFFICERS

Non-Coach Director, Dave Coddington. As Dave's term will expire tomorrow, he expressed his appreciation for the opportunity to serve the Zone.

Coach Director, Sean Redmond. Be aware, there is a possible rule change that would allow the date of the Age Group Championship meet to change because of the change in school closure dates.

Zone Swimming Championship Meet Coordinator, Denna Culpepper. The Age Group Championship meet was hosted by Sierra Nevada Swimming and California Capital Aquatics Club. 331 male athletes, 351 female athletes for a total of 682. 53 officials overall. There were 3,894 individual entries and 496 relay entries. John McGough, Head Coach of Clovis Swim Club reported on the Senior Zone Championship. There were a total of 1,055 athletes with 5,193 individual entries and 292 relay entries. There was a total of 13 records broken. 53 officials worked the meet.

Secretary/Treasurer, Debbie Baldwin. A written report was distributed and reviewed. (see attachment)

Officials Coordinator, Teri White. The numbers of officials participating in the Senior Zone Championship Meet are up. We are at 50% capacity of officials for the Mentor/Mentee Program. The Officials' Reimbursement Program had 9 participants at the Age Group Meet and 5 at the Senior Meet. For the first time EVER we had the same number of officials attend the Senior Meet and the Age Group Meet, thanks to all officials who attended.

Disability Coordinator, Haley Berenaum. No report. Requested all General Chairs contact her in regards to a developmental program for the athletes.

Diversity and Inclusion, Kent Yoshiwara. Thanked all who participate on the committee. Noted that not all LSCs are represented and requested potential participants from those LSCs contact him. Requested the Zone support a travel team to go to Washington DC to participate in the Black History Month meet. Krissy Payton reported that arrangements have been made for the 2018 D&I camp that will be held June 14-17 at San Diego State pool.

Open Water, Jay Anderson. Largest turn out ever, 170 swimmers participated in the meet which was held on Monday, June 19. 13 girls and 8 boys participated in the 10 and under 1K swim. 25 girls and 17 boys participated in the 11-12 2K swim. 18 girls and 11 boys participated in the 13 and older 3K swim. 32 women and 46 men participated in the 5K race.

Athlete Representative, Grant Sugaski. The Western Zone is making huge strides in Athlete Representation within USAS including two who serve on the Athlete's Committee. Unfortunately there are still some LSCs in the Zone that do not have Athlete representation. Joe Gazzarato reported that USAS is hosting an Athlete Leadership Camp in 2018 and each LSC is invited to send two athlete representatives to the camp.

Sean Smith, Senior Development Committee advised that the committee had released dates for upcoming meets and all have been posted on the website. The Western Futures will be 8/2/18-8/5/18 in Santa Clara. The Western Zone Senior Championship meet will be held 7/31/18-8/4/18 in Clovis.

Clint Benton, Governance Committee encouraged everyone to read the Task Force Governance Report and/or attend the Town Hall meeting in preparation for vote at the HOD meeting.

Shelly Rawding, LSC Development Committee advised they had rolled out the Bright Ideas Contest. Winning LSC receives \$1,000.00. Contest runs from 9/14/17 to 6/1/18.

Tony Popp, Sports Medicine and Science Committee is researching injuries in Age Group swimmers. A survey has been sent to all coaches and it is requested that they be completed and returned.
