OLD BUSINESS

Per the section by-laws there must be an athlete member of the section board.

- Requirements:
 - 1. Athlete must have competed in at least one WRS section competition.
 - 2. Athlete is committed to being available for Section Board meetings as necessary for the two-year term.
 - 3. Athlete must be present for election process at summer meeting.
- Recommendations:
 - 1. Athlete has competed in WRS section competitions, including Finals
 - 2. Athlete has previous experience as a club or lsc athlete rep
- Nominations will be taken via email from Section voting members (One coach from each club member, LSC Senior Chair, LSC Senior Athlete Rep) and from the WZ Athlete Reps.
 - 1. Nominations Deadline: June 1, 2024
 - 2. Send nominations via email to Admin VC Jody Broyles
 - 3. Nomination must include a brief biography (one paragraph) of the athlete rep candidate, to share with voting members attending the summer business meeting.

NEW BUSINESS

1) Championship procedures update – National scratch rules – buy back:

Insert in Championship Regulations in Article 1, as a new paragraph, following the existing paragraph on meet entry fees:

USA Swimming Rule 207.11.E(4) applies to this meet. The re-entry fee will be \$200.00 per preliminary event, cash or check payable to the meet host.

*Numbering/lettering of Championship Regulations will be appropriately updated.

It was moved, seconded and approved (38 - 1) to update the championship regulations to be consistent with the national scratch rules.

- 1) Section considered at a future meeting not requiring spring championship meets in Olympic years not be long course due to the addition of other opportunities for the top 1% of athletes to compete in a long course venue. Discussed points included:
 - a. Has been this way a long time came from old Region XII
 - b. Let's see how it goes in 2024 before making any changes
 - c. When put in place there were not as many long course opportunities as there are now.
 - d. Still challenging to find long course opportunities in an Olympic year.
 - e. Even if only one Olympic Trials standard at the meet, it is worth it.
 - f. How many will make it at the 2024 spring sectional meets.
 - g. Possible for one spring meet to be long course and the other short course.
 - h. Possible coordination with senior zone meet.
 - i. Possible short course time trials at the conclusion of the spring meet.

j. Possible prelims as short course and finals as long course.

To be discussed further at the 2024 summer meeting.

3) Future meetings – The next meeting of the section will be by Zoom June 26, 2024 at $12.00 \, \text{PST}$.
