

## Recertification Requirements

Certified officials are required to take the appropriate recertification test/module to recertify every 3 years + sessions

- Stroke and Turn = stroke & turn recertification test +8
- Starter = stroke & turn and starter recertification tests +8
- Referee = referee recertification tests +16 (at least 8 referee)
- Admin Official = admin official recertification test +8

\*Officials In Good Standing 2023 were automatically advanced to 12/31/2026 expiration.

#### Becoming an Apprentice Official

#### Required by Oregon Swimming before on deck

- Register with USA Swimming (pay fee)
- Complete background check
- Complete Athlete Protection Training
- Complete Concussion Protocol Training

#### Best practices (before on deck):

- Foundations of Officiating clinic
- Stroke and Turn module or Administrative Officials clinic
- Apprentice official should reach out to meet referee for training.
- Meet referee should encourage completion of all steps prior to on deck training.
- Meet Referee should review form and check in with apprentice before adding printed name.

All sessions worked as an apprentice should be entered into OTS. A best practice is to check OTS about week after a meet to ensure the meet referee has entered your sessions.

#### Rule Changes approved by USA Swimming HOD

- Jurisdiction of the starting position from the Starter to the Starter or Stroke and Turn Judge
- Counter for 400 SCM

Effective immediately.

- R-2: To modify the jurisdiction of the starting position from the Starter to the Starter or Stroke and Turn Judge - Immediate
- Purpose: To modify the jurisdiction of the starting position from the Starter to the Starter or Stroke and Turn Judge.

#### Page 22 – 101.1.E – STARTS:

shall not be disqualified for an illegal startir the Starter. A swimmer shall be disqualified for an illegal starting position at the start if the swimmer moves from a legal starting position to an illegal starting position immediately prior to or after the "take your marks" command provided that the illegal starting position exists when the signal to start the race is given. Enforcement of the correct starting position is the responsibility of the Starter or the Stroke and Turn Judges.

 R-5: To provide a swimmer the option of a counter in the 16 length 400 SCM freestyle race. This would especially benefit younger and newer swimmers.

Page 31 – 102.6.A – COUNTERS
A swimmer in the 500/1000/1650 yard or 800/1500
400/800/1500 Short Course Meter or 800/1500 Long Course Meter freestyle or other long

#### Rule Changes approved by USA Swimming HOD

#### **Additional Clarifications**

- Exceeded event limits
- 12&U suits can't have any woven fabric
- 12&U swimmers in only one preliminary in a Preliminary / Finals meet
- One toe on wall from each foot

Effective immediately.

- Officials are expected to work 80% of the sessions at the meet including time trials. Officials who qualify for reimbursement must submit receipts to the Western Zone Officials Chair, the monies will be sent to the Officials LSC with a note documenting the official and amount for each official.

\*Review\*

Our input is valuable and will help shape how Meet 360 is implemented at the LSC level

- Prearrange officiating sessions with meet referee
- Officials Membership Card In Good Standing is required to work on deck
- Know when your membership card expires and give yourself extra time to renew
- Stick to the rule book use common sense
