  - Jenn will be checking into a possible issue of pool marshals. SCS might want them to have extra training. This will need to be discussed at the next meeting after more information is given.
    - March is the only committee meet. Jenn will be looking at dual/tri meets to have the swimmers have more opportunities.
    - Several teams have been inquiring about us hosting a Closed Invitational instead
      of/in addition to Kevin Perry to be held in November with heats and finals. We
      would be able to invite teams
    - Relays: As of right now the team pays the entries for relays. We have had many teams scratched because decide at the last minute to not come to the meet.
      - Would like to implement a policy that if a swimmer pulls out of the meet and impacts the relays that swimmer pays for the entire relay; illness exempt. Jenn will work on the wording for January meeting.
    - Travel Trip: Team will be traveling to Far Westerns this April. The meet will be held in Santa Clara from April 4<sup>th</sup> 9<sup>th</sup>.
