Lisa- we had pay increases, Tripp is going to make a more visible role.

Rob- deficit is close to Tripp's moving expenses. Our former treasurer likes percentages, but we rounded up the dues.

Lisa-our dues are still less than other dues.

Lorraine- can we get budget ahead of time? Are the other clubs having better facilities? Rob- RAA has one pool. They have a great deal, but maintenance is bad. We have the flexibility to change pools.

Jen- we have water polo because Mesa wanted a water polo club, and it brings more membership in. Other clubs get moved around, except NCA Carl's Bad is \$400 a month and Mission Viejo.

Rob- other questions on budget? Go over compensation for coaches.

Jen-Storage unit- \$578 a month. Change to a U-Haul place,

maybe \$250 a month.

Lisa- website hosting went down in price

also. Mary- how much are we losing

in the master's class?

Jen- \$12,000. If not

working, we'll reassess. Mary-

we need to promote it more.

Jen- get another flyer going. Shark attack also.

Lisa- To be profitable, we need 18 total swimmers. Now we have 10.

Rob.-Are we set with the meet? Anything else needed?
