   Both Michelle and Patty submitted a proposal<sup>1</sup> MOTION PASSED
- Change to Travel Fund Surcharge Distribution (Proposed Standing Rule Change) Two
  dissents from Todd Marsh and Natalie Geffros<sup>2</sup> MOTION PASSED
- Change to LSC Championship Meets:
  - o SRS Winter Champs (Technical Planning Proposed Standing Rule Changes)
    - Three full days next year as approved by technical planning. No need to pass a motion.
  - o SRS Summer Champs Events Schedule with 13 & O 50's
    - Reinstate 50's qualifying standard times MOTION PASSED
  - Change to Article VII "Conduct of LSC Championship Meets" (Proposed Standing Rule Change)<sup>3</sup>
    - All swimmers entered in the meet must be members of Snake River Swimming
    - Entry time verified in SWIMS. Entry time not found in SWIMS can also be proven using official published results from sanctioned/approved meets. MOTION PASSED
