3. Discussion topics:
 - a. Sponsorship
 - i. Discussed pros and cons of the 2 sponsorship proposals we received, Arena and A3.
 - ii. Came to consensus that Arena would be the best sponsor at this time.
 - iii. Per the request of the BOD, we need to get agreement from the Senior Committee and the Athletes Committee. Dave will request a discussion at the Board meeting on February 9th.
 - iv. Also need to determine who has the authority to approve the contract and commit us to our obligations.

 - iv. Will also attach the summary page with the e-mail.
- d. Summer Swim Clinic for Qualifiers
 - i. Discussed having a swim clinic/practice for qualifiers and provisional qualifiers to the Western Age Group Championships
 - ii. This is something we should coordinate with the Senior Zone Committee. Dave to bring up at the BOD meeting on Monday (2-9)
 - iii. Consensus was to have it earlier in the summer season.
 - iv. Memorial weekend was discussed but concerned arose over a conflict with a meet in Douglas.
 - v. Locations thrown out included Casper, Laramie (new 50 meter pool) and Gillette. Casper because it is in the center of the state. Laramie and Gillette because of 50 meter pools.
