In granting this sanction, it is understood and agreed that USA Swimming, Wyoming Swimming Inc., Casper Swim Club and Kelly Walsh Community Aquatic Center shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.

Whether submitting entries electronically or on paper, by the action of entering the swimmer in this Wyoming Swimming, Inc. meet/event, the person entering the swimmer, whether a coach, team representative, parent or swimmer, certifies that the swimmer is a registered member of USA Swimming and further agrees that a penalty of $\$ 50$ shall be assessed by Wyoming Swimming, Inc. to anyone entering a swimmer who is not registered with USA Swimming prior to the entry deadline.

Host: Casper Aquatic Swim Club, 3500 E. $12^{\text {th }}$ Street, Casper, Wyoming 82609
Location: Kelly Walsh Community Aquatic Center, 3500 E. $12^{\text {th }}$ Street, Casper, Wyoming 82609. The pool parking lot is off Walsh Street, South of the Aquatic Center. The pool entrance is on the south side of the pool building.

Coaches and Officials meetings will be held in the back room of the pool's office
Pool: Indoor 25 -yard, 8 lane pool equipped with non-turbulent lane markers, starting blocks, and backstroke flags. At starting end of pool, the depth measured at the start end is $12^{\prime}$ at $3^{\prime} 3.5^{\prime \prime}$ to $12^{\prime}$ at $16^{\prime} 5^{\prime \prime}$ from starting end. The pool depth is $3^{\prime} 6^{\prime \prime}$ deep at $3^{\prime} 3.5^{\prime \prime}$ from turn end of pool to $4^{\prime} 0^{\prime \prime}$ at $16^{\prime} 5^{\prime \prime}$ from turning end.

The competition pool has been certified in accordance with 104.2.2c (4). The copy is on file with USA Swimming.

Timing: Colorado Timing System, with 8 lane scoreboard and semi-automatic backup, and 2 manual back up timers per lane. All clubs will be expected to provide timers based on the number of swimmers their club has participating in the meet.

Rules: Current USA Swimming rules, including the Minor Athlete Abuse Prevention Policy ("MAAPP"), will govern this meet.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Except where venue facilities require otherwise, changing into or out of swimsuits other than in the locker rooms or other designated areas is not appropriate and is prohibited.

Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, or locker rooms.

Operation of a drone, or any other flying apparatus, is prohibited over the venue any time athletes, coaches, officials and/or spectators are present.

Eligibility: No swimmer will be permitted to complete unless the swimmer is a member as provided in the USA Swimming Article 302.

There will be NO on-deck registrations.
Age Groups: Swimmer's age will be determined by his/her age on the day of the meet, November 18, 2022.
*8 \& Under, 9-10, 11-12, 13-14, 15 \& Over. *8 \& Under is not a recognized USA Swimming Age Group -USA Rule 102.1.2. All events will be swum mixed with published results separated for each age group and gender.

Scoring: Individual swimmers will be scored on the combined time totals in all five events.

Awards: Custom Medals will be awarded to the top five (5) girls and top five (5) boys in the following age groups: 8 \& Under, 9-10, 11-12, 13-14, 15-16, 17 \& Over.

Each swimmer must swim all five (5) individual events in order to be eligible for individual awards. Swimmer's five (5) times will be totaled into a combined time and the fastest five (5) will receive individual awards as described above.

Swimmers who choose not to swim all five events will not be eligible for awards, but are allowed to swim for time.

If a swimmer disqualifies in an event, a 10 percent time penalty will be added for that event.
Entries: All events will be pre-seeded timed finals.
Please submit entry times in yards.
Entry Fees: $\quad \$ 35.00$ per swimmer (which includes $\$ 8.00$ per swimmer WYSI Participation Fee and a $\$ 3.00$ pool usage fee). There will be no refunds. Make checks payable to Casper Swim Club.

Deadline: Entries MUST be received by 11/10/2023. Late entries will not be accepted. Please submit a check for entry fees payable to "Casper Swim Club," hard copies of the entries, and the USA Registration compliance form. Please include contact information. There will be no refunds.

Officials: Each WYSI (Wyoming Swimming, Inc) club shall provide official(s) to work the meet based on the number of swimmers entered into the meet: 1-9 Swimmers - No official required, 1017 Swimmers - One official, 18-25 Swimmers - Two officials, 26 or more Swimmers Three officials.

When submitting their entries to the host club, each WYSI club shall also provide to the host club the names of the official(s) who will be representing their club at the meet.

Timers: Clubs will be assigned lanes for timing proportionate to the number of swimmers they have entered.

After receipt of a club's entries, meet management shall notify clubs as to the lane and session assignments for timers from their club. Please have your timers ready to go!

Warm Ups: Warm up procedures will comply with USA Swimming and Wyoming Swimming, Inc. Dive Starts will be allowed only during the last five (5) to ten (10) minutes of each warm up. USA Swimmers must be under the supervision of a coach at all times. A schedule of Warm-up times and Lane Assignments will be determined after the entry deadline when the number of contestants has been determined. The Warm-up Schedule will be emailed to all coaches no later than 3 days prior to the meet.

Concessions: There may be limited individual serving concessions.
USA Cards: ALL COACHES AND MEET OFFICIALS MUST WEAR THEIR USA SWIMMING CARD IN PLAIN VIEW AT ALL TIMES OR AVAILABLE VIA DECK PASS.
