# **SECTION 9**

#### Section A

#### Current:

<u>ANNUAL ATHLETE REGISTRATION</u>: Each athlete, non-athlete, or administrative member registering with Wyoming Swimming shall do so using the SWIMS 3.0 platform maintained by USA Swimming. In addition to any registration fees required by USA Swimming, each athlete shall pay an annual registration fee to WYSI of \$7.00.

## Proposed:

<u>ANNUAL ATHLETE REGISTRATION</u>: Each athlete, non-athlete, or administrative member registering with Wyoming Swimming shall do so using the SWIMS 3.0 platform maintained by USA Swimming. In addition to any registration fees required by USA Swimming, each athlete shall pay an annual registration fee to WYSI of \$8:00, of which \$1 will go to support Outreach Athlete Meet Reimbursement.

#### **Section C**

### Current:

<u>MEET PARTICIPATION FEE:</u> A participation fee is required of every swimmer entering a WYSI sanctioned meet. The participation fee is \$8.00 regardless of the length of the meet.

### Proposed:

MEET PARTICIPATION AND FACILITY USE FEES: Teams may assess a participation fee and a facility use fee. A participation fee is required of every swimmer entering a WYSI sanctioned meet. The participation fee is \$8.00 regardless of the length of the meet. Participation fees for WYSI Championship events are \$26, \$1 of which is designated for Outreach purposes.

If a facility use fee is charged, a facility invoice must be provided with the financial report. Fees received must be equal to or less than the fees charged. If fees received are in excess of the fees charged, then the overage must be paid to WYSI. IF the invoice is not provided and any overages are not paid, no further sanctions will be issued until this is paid.

## NON-CHAMPIONSHIP MEET EVENT ENTRY FEES:

- 1. The maximum amount that may be charged for a non-championship individual event is \$8; relay events are \$14.
- 2. The maximum amount that may be charged for a District Championship individual event is \$10 relay events are \$16
- 3. Entry fees may never be more than the preceding WYSI Championship event fees.

4. Flat fees may only be charged for intra-squad, dual and tri-meets. Una ached swimmers do not factor into determination of the type of meet.

## Current:

WYSI CHAMPIONSHIP EVENT ENTRY FEE - The entry fee for each event of a WYSI championship is \$7.00. The entry fee for each relay event will be \$12.00

WYSI CHAMPIONSHIP EVENT ENTRY FEE - The maximum amount that may be charged for an individual event is \$12 and relay events are \$18
