

## **Technical Suit Policy**

Swimmers Competing as 13 & Overs / Updated March 2021

### Speedo Fastskin LZR Pure Intent For YMCA National Qualifiers Only

- · Allowed at National level competitions.
- Allowed at CT Senior & Age Group Championships.
- May also wear suit at other meets and finals sessions at coach discretion.
- Triple-fabric construction enhances compression and flexibility.
- Shark skin-mimicking texture creates micro vortices along suit's surface.
- · Team color for this suit is black.

## Speedo Fastskin LZR Pure Valor

### For 13 & Over CT Senior & Age Group Qualifiers

- · Allowed at CT Senior & Age Group Championships.
- May also wear at other prelims/finals meets at coach discretion.
- Swimmers with CT Seniors or 13 & Over Age Group Championships qualifying times, may also wear suit at Regionals.
- Provides maximum flexibility, greater range of motion and core stability through layered fabric.
- Feel lighter and ride higher in the water for optimal body positioning.
- Team color for this suit is black.

## Speedo LZR Pro Recordbreaker For 13 & Over Regional Qualifiers

- · Allowed at CT Regionals
- May also wear suit at other prelims/finals meets at coach discretion.
- · Water repellent, chlorine resistant, and fast drying.
- · Provides muscle efficiency.
- · Suit has visibly stitched seams.
- · May choose version of suit with different colored leg.
- Team color for this suit is "Primarily Black."

## For 11-12 FEMALE Age Group Qualifiers

- May wear at finals sessions of other meets at coach discretion.
- · Suit has visibly stitched seams.
- Team color for this suit is "Primarily Black."
- No kneeskins for 12 & Under Girls





# Speedo Vanquisher Jammer For 11-12 MALE Age Grou

## For 11-12 MALE Age Group Qualifiers

- May wear at finals sessions of other meets at coach discretion.
- · Suit has visibly stitched seams.
- · Team color for this suit is Black.

### Speedo Aquablade For 10 & Under Swimmers

- · Allowed at CT Age Groups.
- · Allowed at CT Regionals.
- · May wear at other bigger meets at coach discretion.

### For 11-12 Swimmers

- · Allowed at CT Regionals.
- · May wear at other bigger meets at coach discretion.
- · Suit appears to have vertical stripes.
- · Team color for this suit is black.





### Speedo Fastskin 2 (FSII)

### For 11-12 Swimmens

- This is a less expensive alternative to the Speedo LZR Pro or Speedo Vanquisher.
- This suit has been nicknamed "sharkskin" because of its appearance.
- Team color for this suit is black and gray.
- This suit has been discontinued but may still be available on some websites.
