Describe the local and facility safety protocols surrounding the meet.

The meet will adhere to the COVID-19 requirements as set forth from the governor of Iowa in her September 17, 2021 proclamation. At the Wellmark YMCA facilities, the following protocols and practices are in place:

Effective Friday, August 6^{th} , The Greater Des Moines YMCA updated the COVID-19 procedures related to entrance into our facilities and face mask guidelines.

- Current Wellmark YMCA policy is for ALL staff and volunteers working in INDOOR
 events that serve youth under the age of 12 will be required to wear a mask on
 deck if you are unable to ensure at least 6 feet of social distancing.
- Signs posted at the entrances of each of our facilities. These signs will ask people to help reduce the spread of illness by NOT entering the facility if they:
 - o have tested positive for COVID-19 within the last 10 days,
 - o are experiencing any of the symptoms associated with COVID-19; or
 - have had close contact with someone else who has tested positive for COVID-19 within the last 14 days.
 - Hand sanitizer (provided by the Y) at entries to the building.
 - Face masks are recommended but not required.
 - Teams may request socially distanced sections in spectator seating sections 9&10.
 - Warmup lanes will be assigned to each team. The warmup/cool down pools will have a max of 7 per lane during competition.
 - For competition, one heat on the blocks and up to two heats socially distanced along the west side of the pool "ready wall". After a race, swimmers will remain in the water until the next heat does a fly-over start.
 - All swimmers will exit the pool deck from the Grand Ave doors or the Skywalk exit on the upper level of spectator seating; keeping with the one-way entrance and exit plan.
 - A deck guard will provide a first aid station and also attend to a routine schedule of disinfecting high touch point areas throughout the meet.

<u>Describe your plan for the entry and exit of spectators, if permitted AND Spectator Seating, if any: Include plans made to maintain social distancing guidelines:</u>

• Spectators may be limited or not be allowed to sessions if athlete numbers require the spectator stands to maintain social distancing.

The planned number of individuals gathering in the following locations:

<u>Pool Deck, including coaches, athletes, officials and volunteers: Include plans made to maintain social distancing guidelines:</u>

- Pool deck athletes: 300+ spaces for swimmers, Teams may request socially distanced seating for their athletes in the spectator stands -sections 9&10.
- Hospitality for coaches and officials will be in the conference room east of the pool. The wet classroom will be available for officials.
- Pool deck coaches (all in face masks for 12&U Sessions)
- Officials (all in face masks and socially distanced for 12&U Sessions): 10-12 officials expected per session.
- Volunteers (all in face masks for 12&U Sessions): meet marshals; announcer and timers (one per lane).
- Aquatic event staff & lifeguards will be on deck and face-masked if not socially distanced.

<u>Safe Sport considerations ensuring a parent has access to their child and/or may observe their child:</u> These may include ensuring all parents have a reliable mobile number to contact a coach on deck if the athlete does not have a phone, or a single contact number for the facility director.

- DSMY will live stream the meet on our YouTube channel.
- In the meet invite, the meet director's contact information is provided.
- DSMY is a certified Safe Sport Team and will adhere to the protocols and policies in place including MAAPP.
