

Travel and Transportation Policy

The Flashes Aquatics Travel policy is designed for the safety of all club swimmers and coaches when traveling.

Section 1 - USA Swimming Required Policies

Club and LSC travel policies must include these policies. These items are Code of Conduct stipulations in the USA Swimming Rulebook.

- a) Club travel policies must be signed and agreed to by all athletes, parents, coaches and other adults traveling with the club. (305.5.D)
- b) Team managers and chaperones must be members of USA Swimming and have successfully passed a USA Swimming-administered criminal background check. (305.5.B)
- c) Regardless of gender, a coach shall not share a hotel room or other sleeping arrangement with an athlete (unless the coach is the parent, guardian, sibling, or spouse of that particular athlete). (305.5.A)
- d) When only one athlete and one coach travel to a competition, the athlete must have his/her parents' (or legal guardian's) written permission in advance to travel alone with the coach. (305.5C) It is herby the stated policy of Flashes Aquatics that transportation of swimmers and/or coaches to practice, meets, or any other event considered to be a club function by any non-public conveyance, as defined to include privately owned vehicles, is recognized by Flashes Aquatics as a purely private agreement between the parties involved and that neither the Flashes Aquatic club, nor the Flashes Aquatics Board of Directors, separately or as a group, except for the parties directly involved can be or will be considered as a party to such arrangement and that any liability to any form arising from such arrangement is purely and completely the responsibility of the parties involved.
