#### Review of previous notes and Y State survey

The meeting focused on reviewing team numbers and discussing the process for managing swimmer registrations and participation. Earl presented an agenda covering topics like the treasure report, minutes, calendar updates, and contact list updates. Tom and Earl discussed the challenges of controlling team numbers, including the issue of allowing time trials or practice times as alternatives to the two-meet minimum requirement. Earl and Shannon provided an update, sharing that the PSSA team count had reached 790, and the Y State estimates numbering 522. They agreed to review the Google form formulas and discuss drawing lines on registration timelines to manage numbers effectively. The results of the survey are attached at the last page of this document.

The group briefly reviewed September meeting minutes, confirming name changes and discussing any edits. Tom led the agenda, and confirmed with Joseph that all name changes had been processed for the previous notes.

#### **Treasurer's Report and Meet Schedule**

The meeting covered the Treasurer's Report, where Marilyn explained the financial status and process for meet fees, clarifying that costs are based on initial entries rather than actual attendance. The updated swim meet schedule was discussed, with upcoming meets in December and January, including the Y-State meet on January 24th. The board emphasized the importance of keeping the contact list current, as many coaches and staff changes had already been reported. Tom encouraged all teams to reach out if they needed help organizing meets or had questions about the schedule.

# **Official Training and Event Updates**

The meeting discussed the prioritization of contact list updates, with Jan requesting email notifications for changes. Earl presented updates on officials' training, noting a net loss of Level 1 officials but highlighting efforts to recruit new ones through virtual and in-person classes. Tom emphasized the need for more officials and encouraged coaches to schedule training sessions. The group also discussed Y-State, an upcoming event with specific eligibility requirements, including a need for swimmers to compete in two meets by January 13th to qualify.

#### **Y State Planning and High School Swimmer Waiver Process**

The group discussed the continuation of high school swimmer exceptions for meet attendance from the previous year, with Joseph asking about the 2 meet requirement and the waiver process for swimmers who cannot attend two meets due to conflicts. David Baer clarified that the state meet must be sanctioned as a championship meet to allow athletes to qualify for Nationals, requiring the 90-day rule, while non-championship meets only need 30 days of membership. Earl and Tom planned to obtain criteria used at the national level to ensure consistency in the waiver process. The planning committee was tasked with finalizing these requirements, as well as working on championship clothing logistics. The meeting also covered registration updates, with most teams having submitted their estimates, though a few still needed to provide their numbers.

#### **Swimming Coach Certification and Succession**

The meeting focused on coach certification requirements and succession planning for swimming officials. Tom outlined the necessary certifications for new coaches, including lifeguard training, safety training, CPR, first aid, and child abuse protection training. Earl discussed mentoring new officials, including Josh Barnhart and Tim Ragulsky, to prepare them for leadership roles in future meets. The group emphasized the importance of promoting new people to Level 1 positions and assessing leadership interests among existing officials. The next meeting was scheduled for January 13th as a pre-coaches meeting for the upcoming meet, and attendees were encouraged to share the information with other coaches and aquatics directors.

## Adjournment and next meeting

The group concluded with planning to keep the Y State start time at 10 AM and limit teams to 3 relays per event. Shannon and Nicole confirmed they could manage deck control for 500+ swimmers. The group also agreed to maintain the 3 individual event limit per swimmer. The group scheduled their next planning meeting for December 2nd at 6:30 PM, combining the planning and executive board meetings. The meeting ended after a celebration of Earl's birthday, sung with lots of heart but jumbled timing through the Zoom delays.
